Madam/Sir,

Kindly refer to this Ministry letter of even number dated 22.11.2016 enclosing therewith the communication No.M-11/16(2)/2015- VAC dated 17.10.2016 from NITI Aayog on the subject cited above (copy enclosed).

2. As per the directions of NITI Aayog, all NGOs/VOs, which are receiving grants from Government of India for implementation of different schemes, are required to registered on NGO-DARPAN Portal and obtain Unique ID after furnishing the requisite details.Under NCLP Scheme, the Government of India releases Grant-in-aid directly to District Project Societies who in turn may engage NGOs/VOs as implementation agencies to run the Special Training Centres (STCs) in the District.

3. In view of above, vide above letter dated 22.11.2016, all the District Project Societies were requested to ensure compliance of the said directions of NITI Aayog and to submit the action taken report accordingly. However, the reports from District Project Societies are still awaited.

NGO-DARPAN Portal and obtain Unique ID after furnishing PAN of the organization and
PAN & Aadhar details of at least three office bearers of such entity.

4. It is, therefore, requested to ensure the compliance of above directions of NITI Aayog,
vide above referred communication, while implementing the NCLP Scheme in the District.
Further, the requisite information/ action taken report in the matter may be sent to NITI
Aayog immediately under intimation to this Ministry.


Reference is invited to NITI Aayog's OM of even number dated 03.10.2016 forwarding a copy of Minutes of the Meeting held on 27.09.2016 under the Chairmanship of CEO, NITI Aayog, regarding Unique ID for the NGOs/ VOs through NGO-Darpan Portal of NITI Aayog for processing of their applications for consideration of grants under various schemes implemented through NGOs/ VOs by different Departments/ Ministries.

2. The progress in the matter is being reviewed at the highest level. Based on the decisions taken in the meeting held on 27.09.2016, it is requested that the following information may kindly be furnished at the earliest:-

- (i) Confirmation that no financial grants have been disbursed after 27.09.2016 to the NGOs/VOs without having a system generated Unique ID from the NGO-DARPAN portal of NITI Aayog, including cases where part grants had been released earlier.
- (ii) Confirmation that communications have been sent to the NGOs which were sanctioned grants in the past to sign-up on NGO-DARPAN Portal, to obtain the Unique ID after furnishing PAN number of the Organisation and PAN and Aadhar details of at least three office bearers of such entity.
- (iii) Confirmation that State/UT governments have been advised to ensure that NGOs/ VOs sign-up on the NGO-DARPAN Portal of NITI Aayog and obtain the Unique ID after furnishing the requisite PAN and Aadhar details in cases where grants are released to the State Governments (rather than directly to the NGOs/ VOs), and the State Governments in turn implement the schemes/ programmes through the NGOs/VOs.
- (iv) Status of action taken to revisit the existing Schemes and make provision for the time-lines, if not done already, within which the grant receiving entities must submit their Utilisation Certificates.
- (v) Status of action taken for initiating Business Process Re-engineering (BPRs) of internal processes as the starting point for development of back-end IT based applications.

- (vi) Status of action taken to develop IT applications for end-to-end processing of applications from the NGOs/VOs for sanction/ release of grants and the likely date by which it shall be ready. It may be noted that all applications have to be processed in online mode only from after 31st March 2017.
